voter trends.**

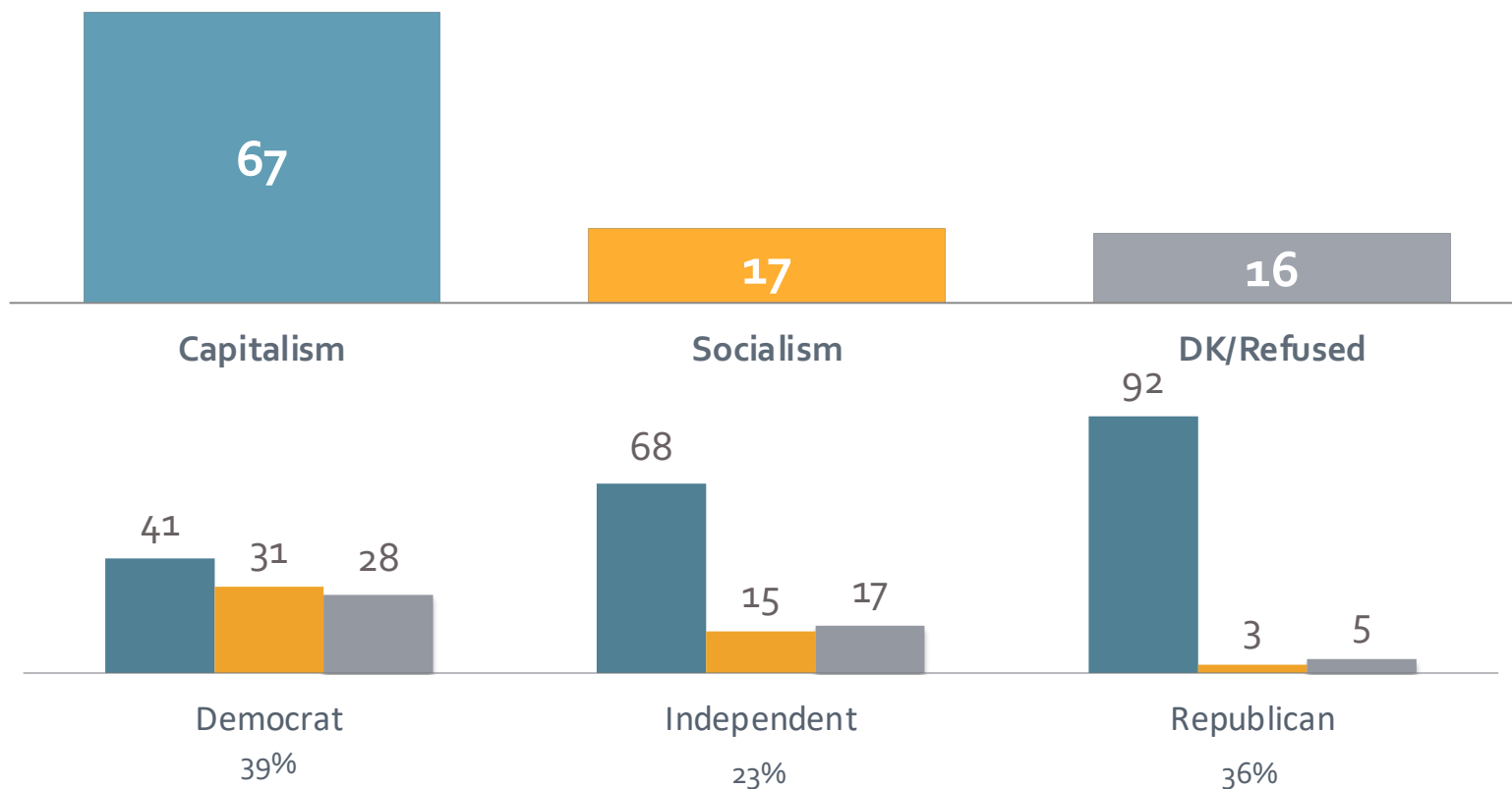
**Margin of error for these surveys is +/- 2.82%.**

Thinking about different forms of government, which of the following statements do you agree with most?

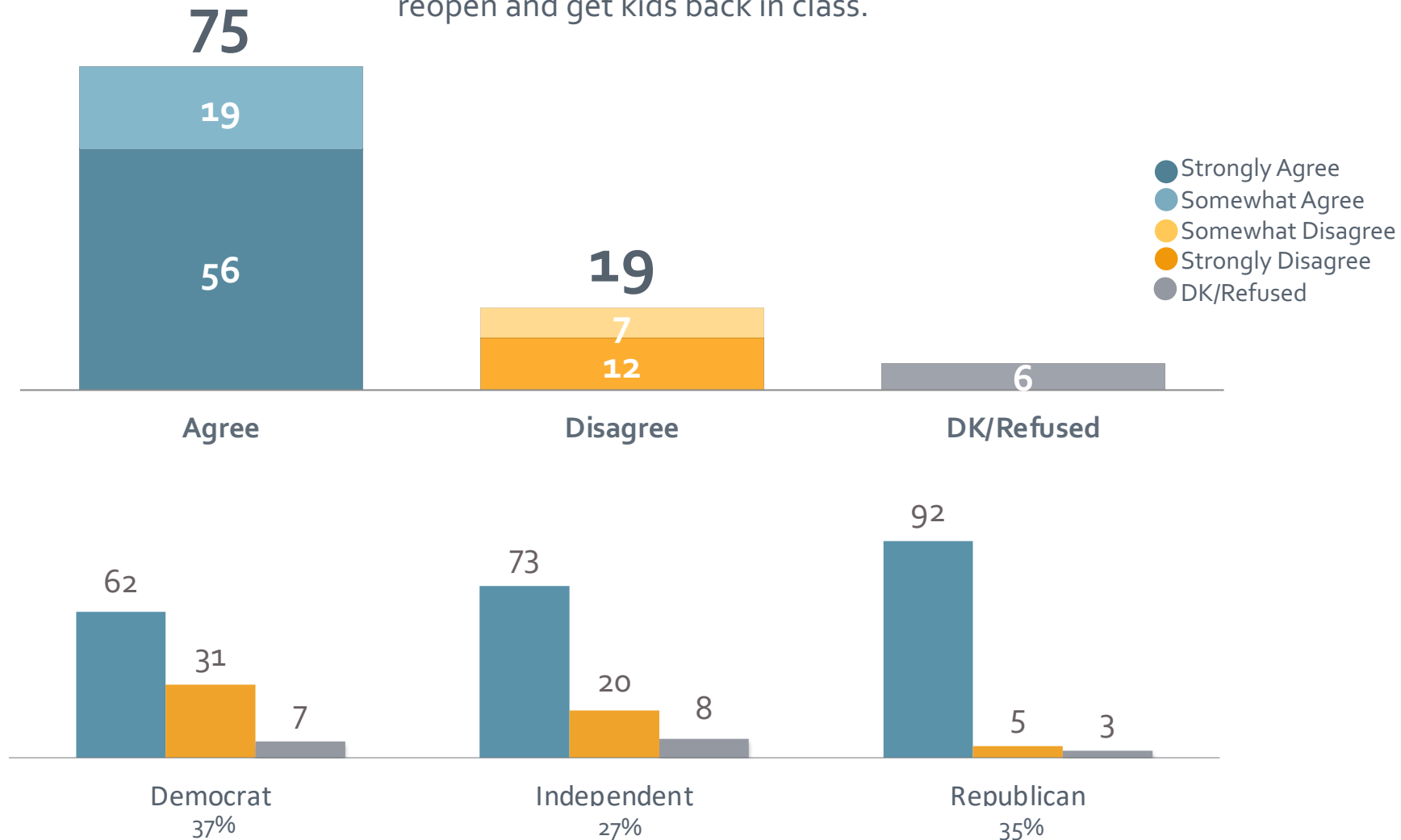
Some people say free market capitalism is the best form of government because it gives people the freedom to work and achieve their potential.

Other people say that socialism is the best form of government because it is more fair and equitable to working class people.



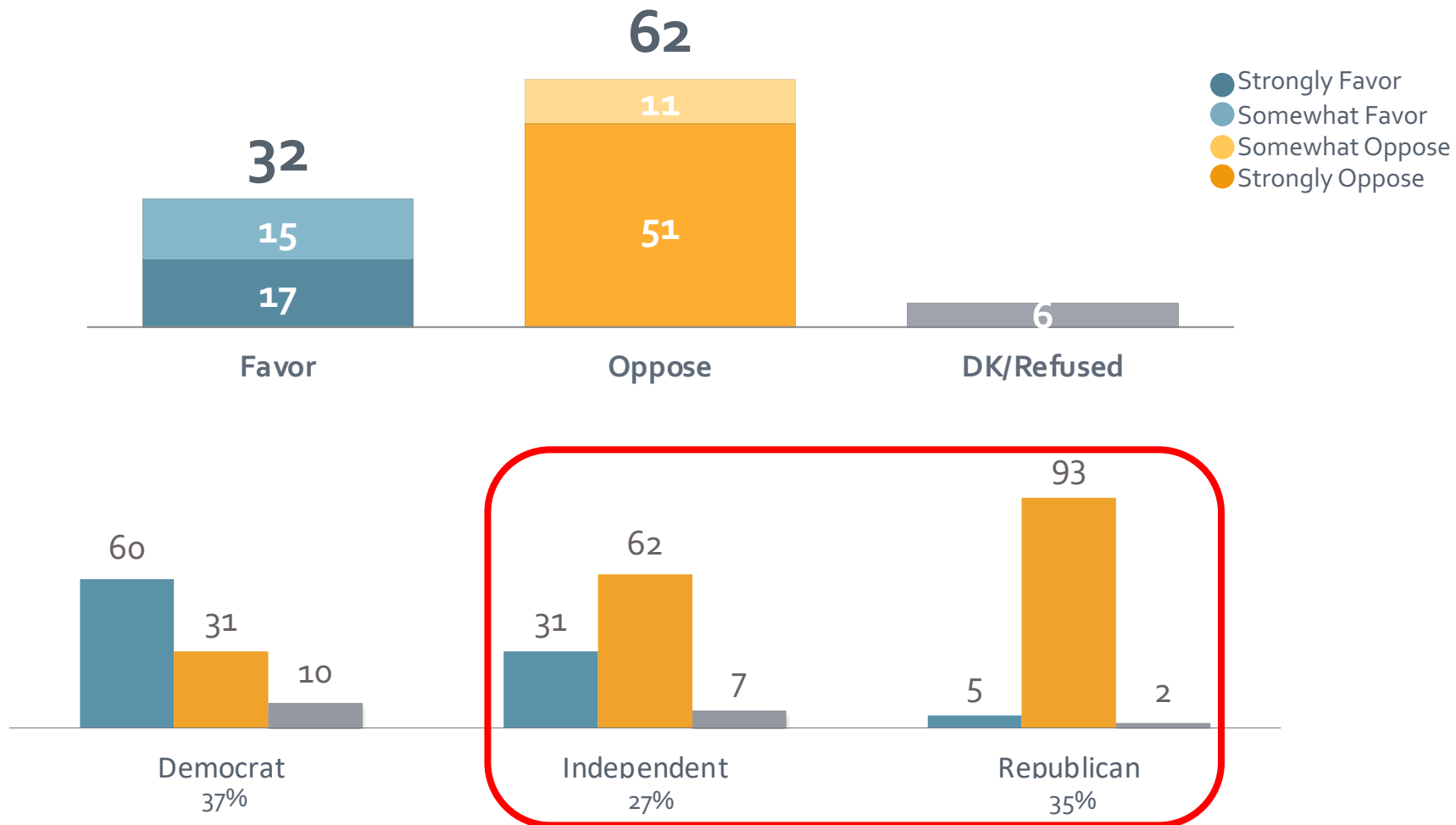

Cutting funds for border security, ending deportation, and giving amnesty to 11 million illegal immigrants.

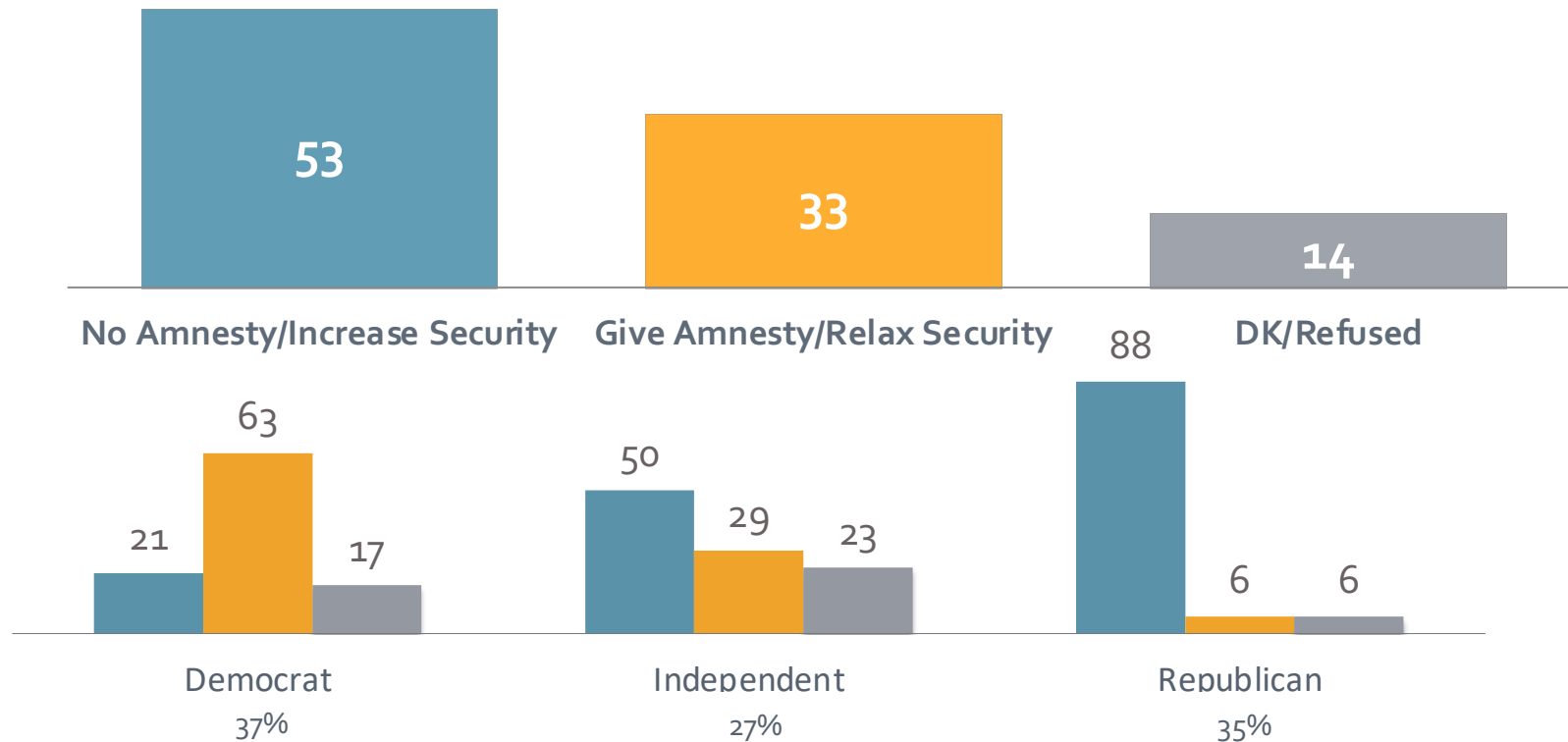


# ILLEGAL IMMIGRANTS IN AMERICA

Thinking about immigration and the 11 million immigrants currently in America illegally, please tell me which of the following comes closest to your opinion.

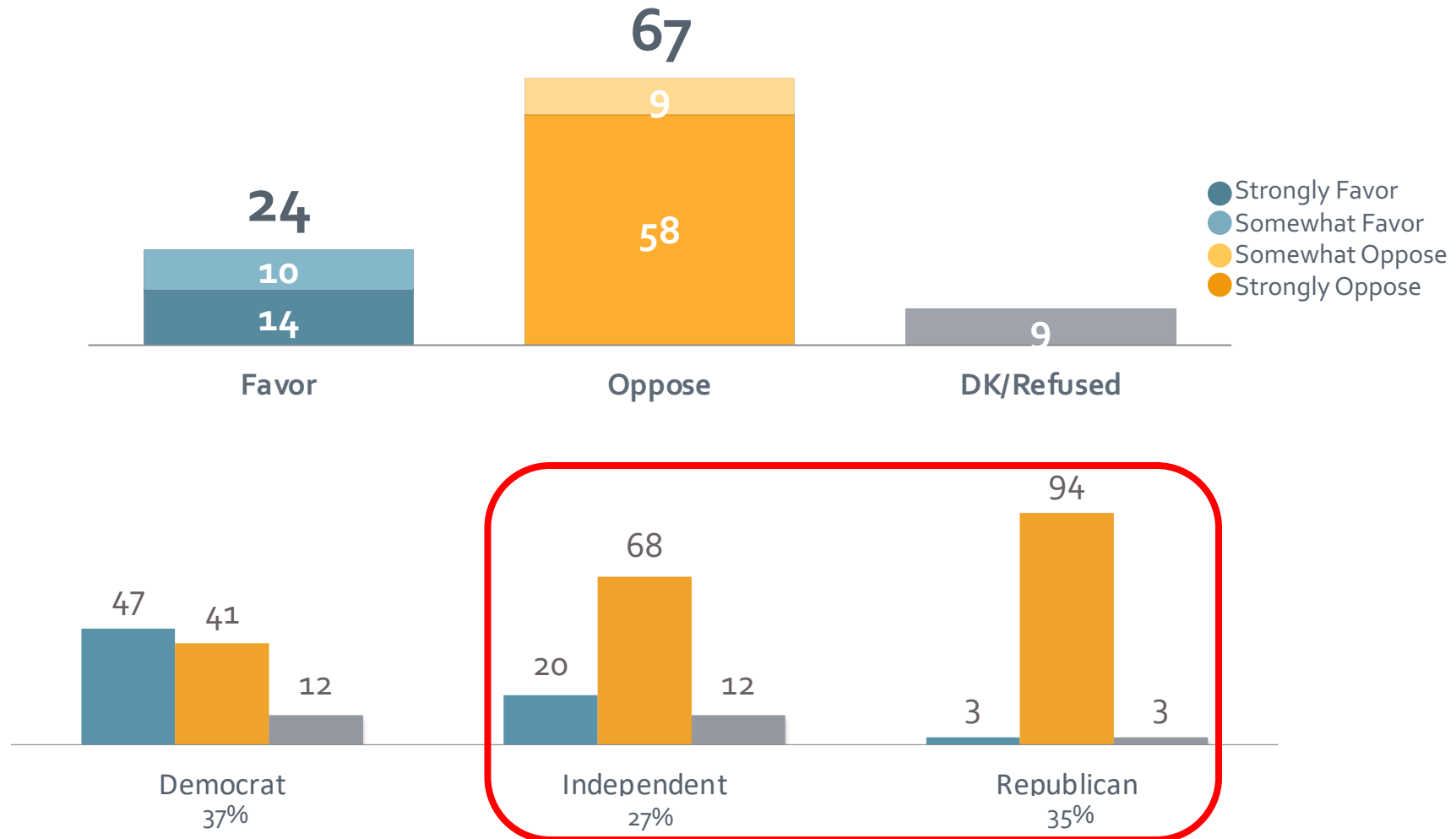

We should give the 11 million illegal immigrants amnesty and a pathway to citizenship, stop all deportations, and cut funding for border security to allow these people to come out of the shadows.



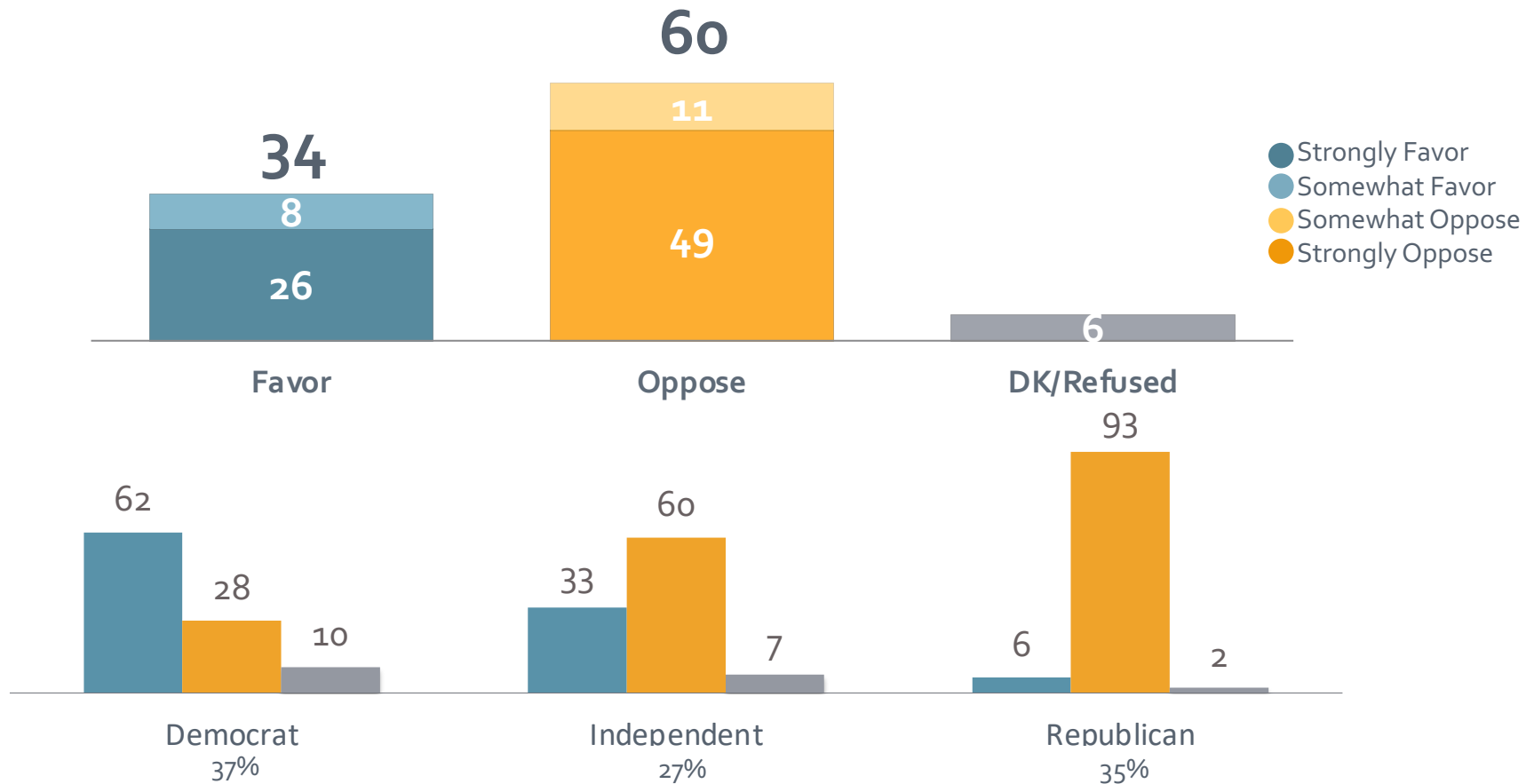
# BIDEN EO/PLAN: MEN PLAYING FEMALE SPORTS

An executive order ending construction of the Keystone XL pipeline eliminating over 10,000 well-paying jobs.



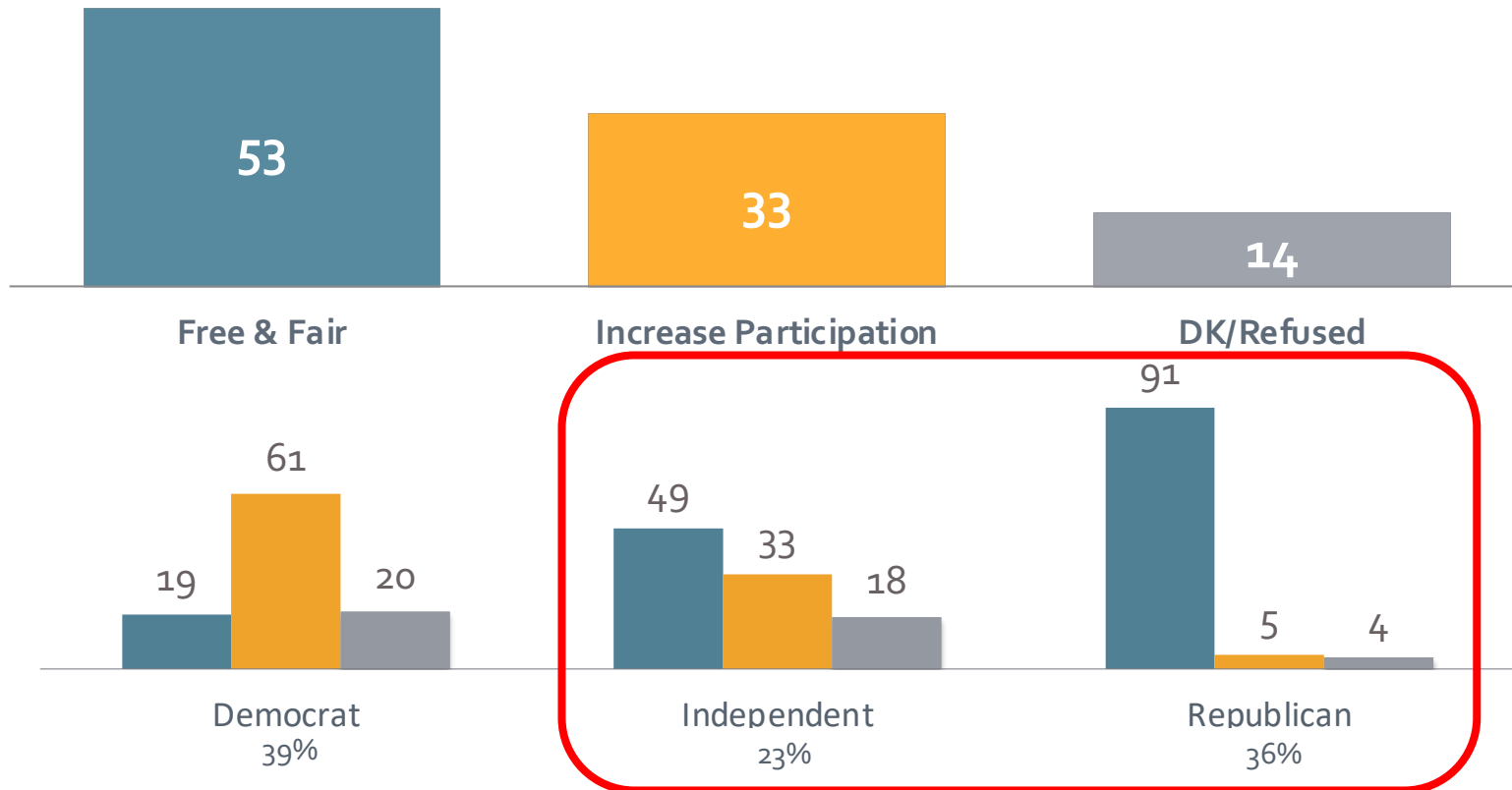

Ensuring that all elections are fair and free of voter fraud.

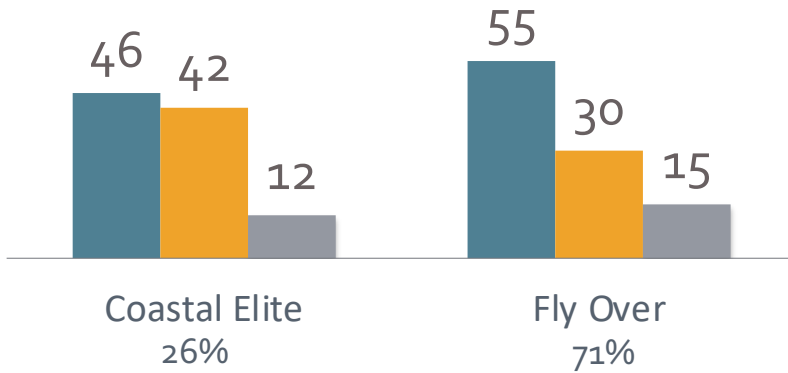

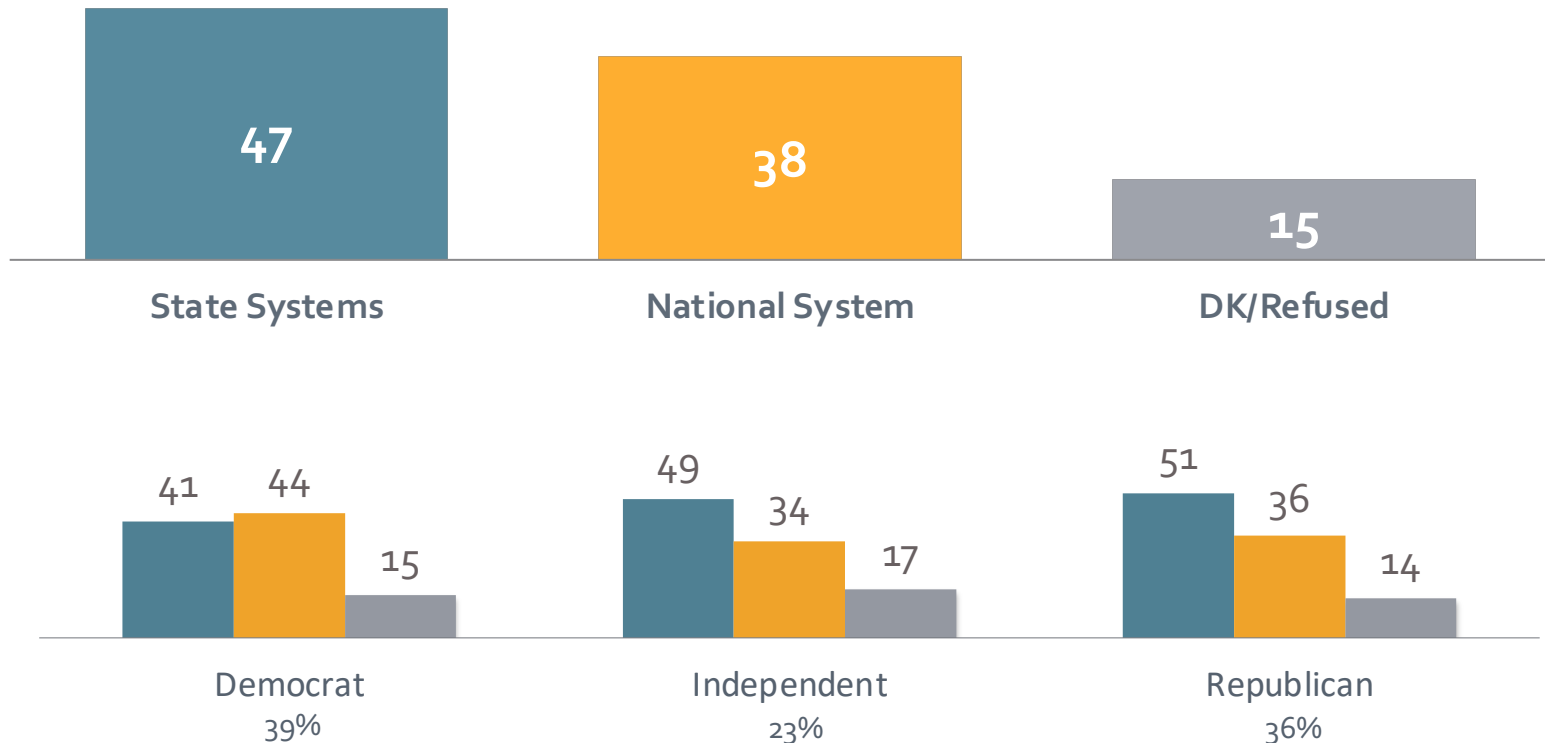


# NATIONAL VS. STATE SYSTEMS

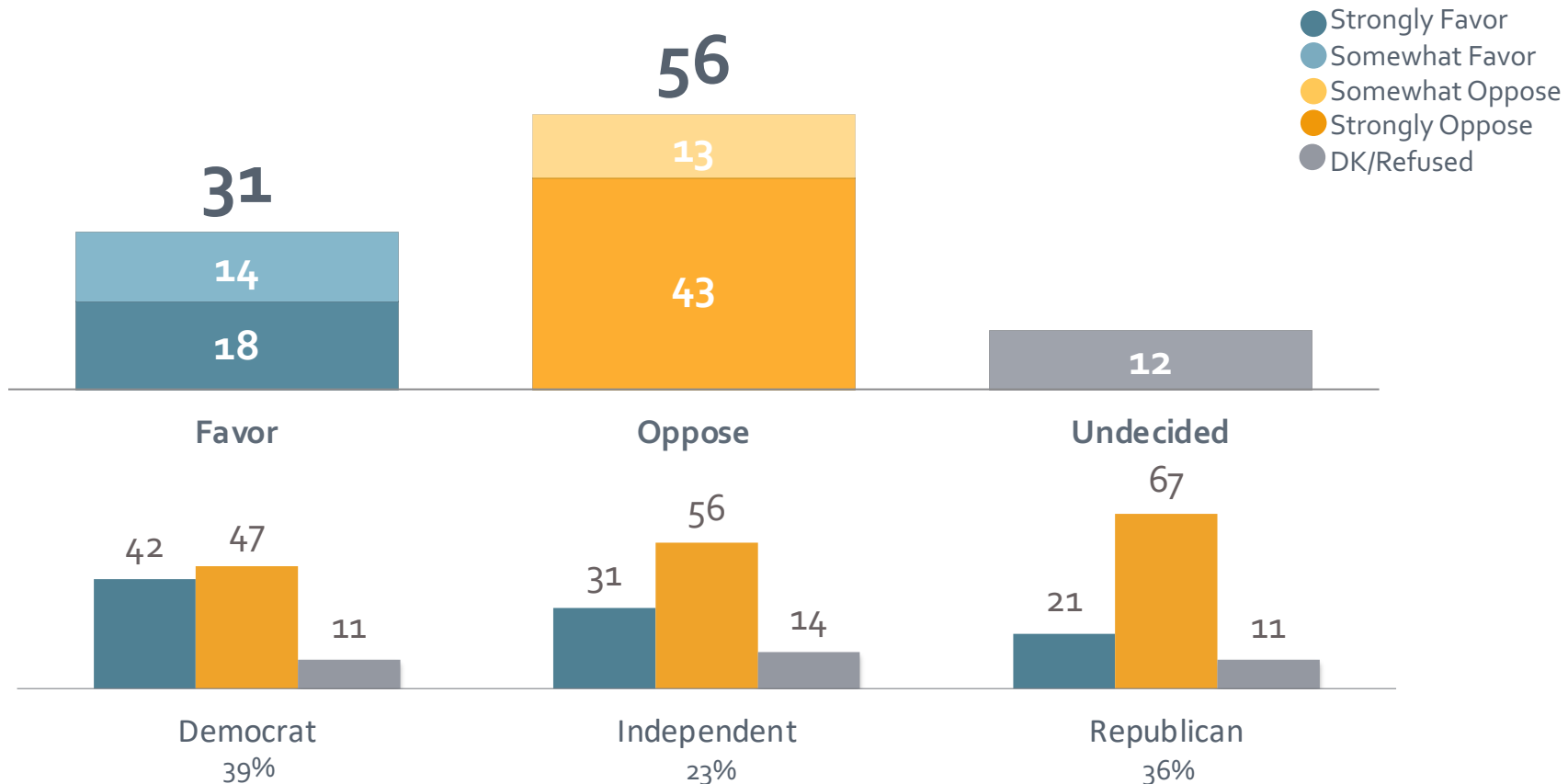
We should not institute a national election system because the constitution gives that responsibility to the states.

We should institute a national election system because the patchwork of state systems makes it difficult, if not impossible, to ensure elections are fair and secure.



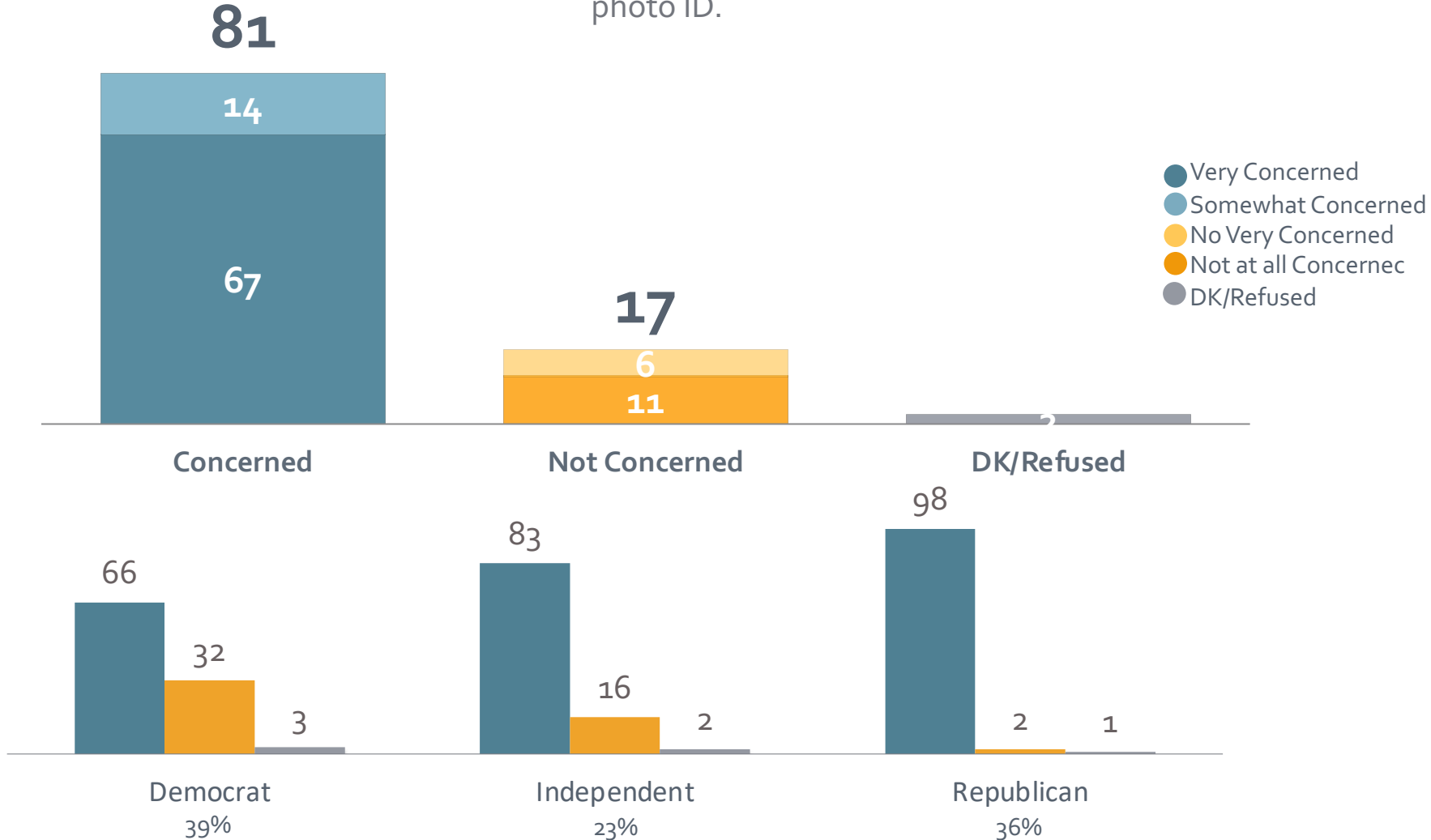
# ELECTIONS FUNDED BY TAX DOLLARS

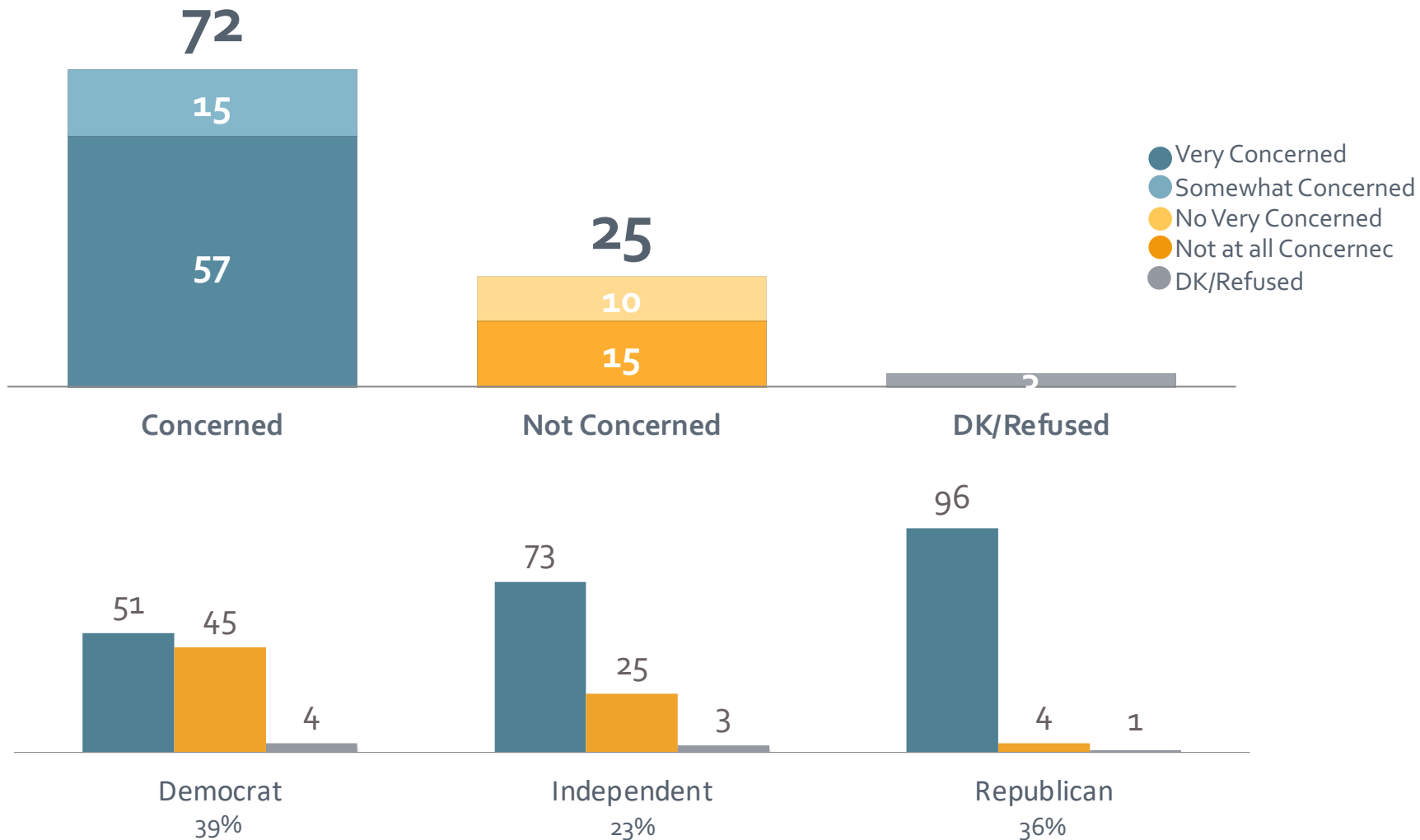
# CONCERN SERIES – SAME DAY REGISTRATION

Not requiring a photo ID or any other identification for those requesting an absentee ballot.

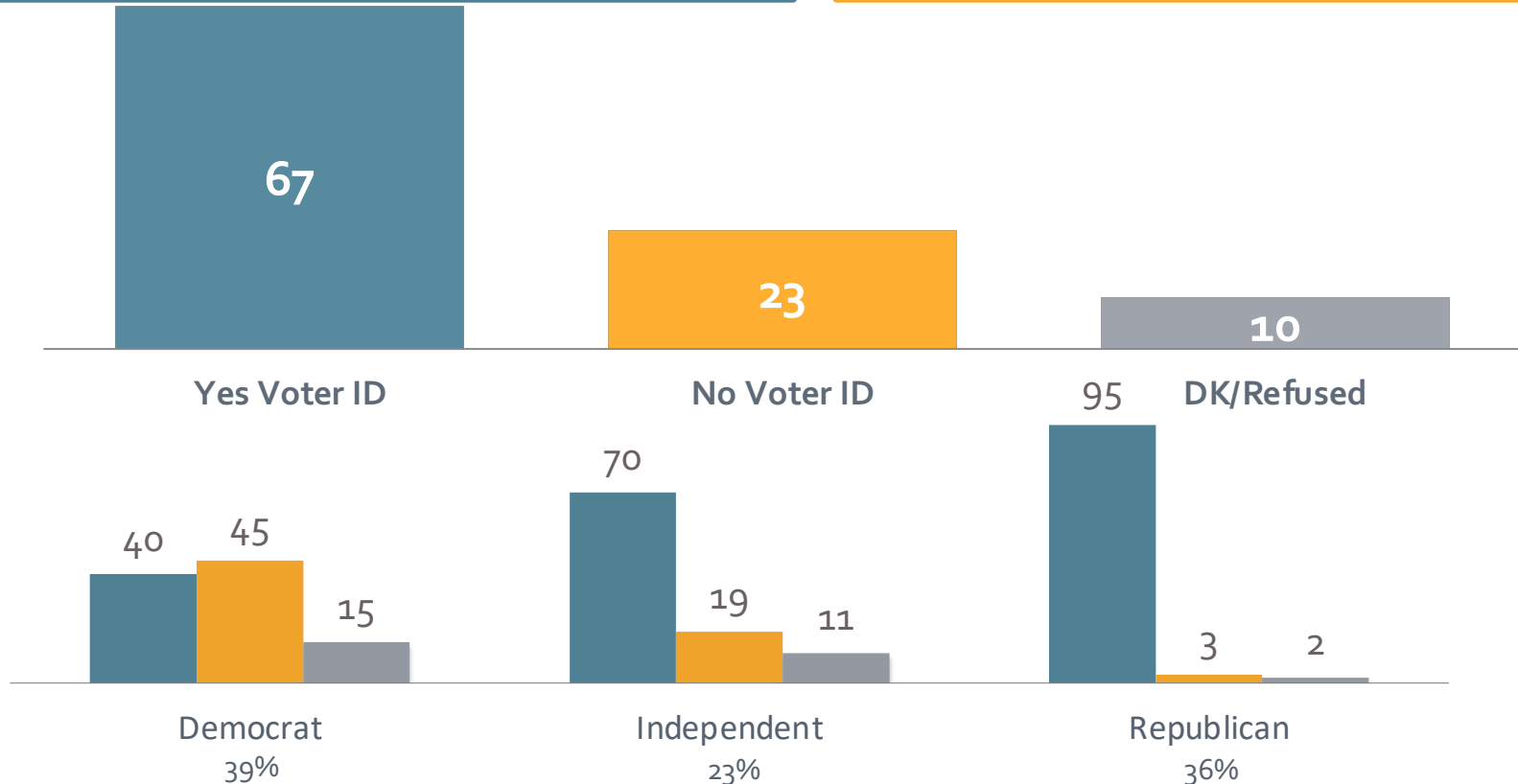


# VOTER ID

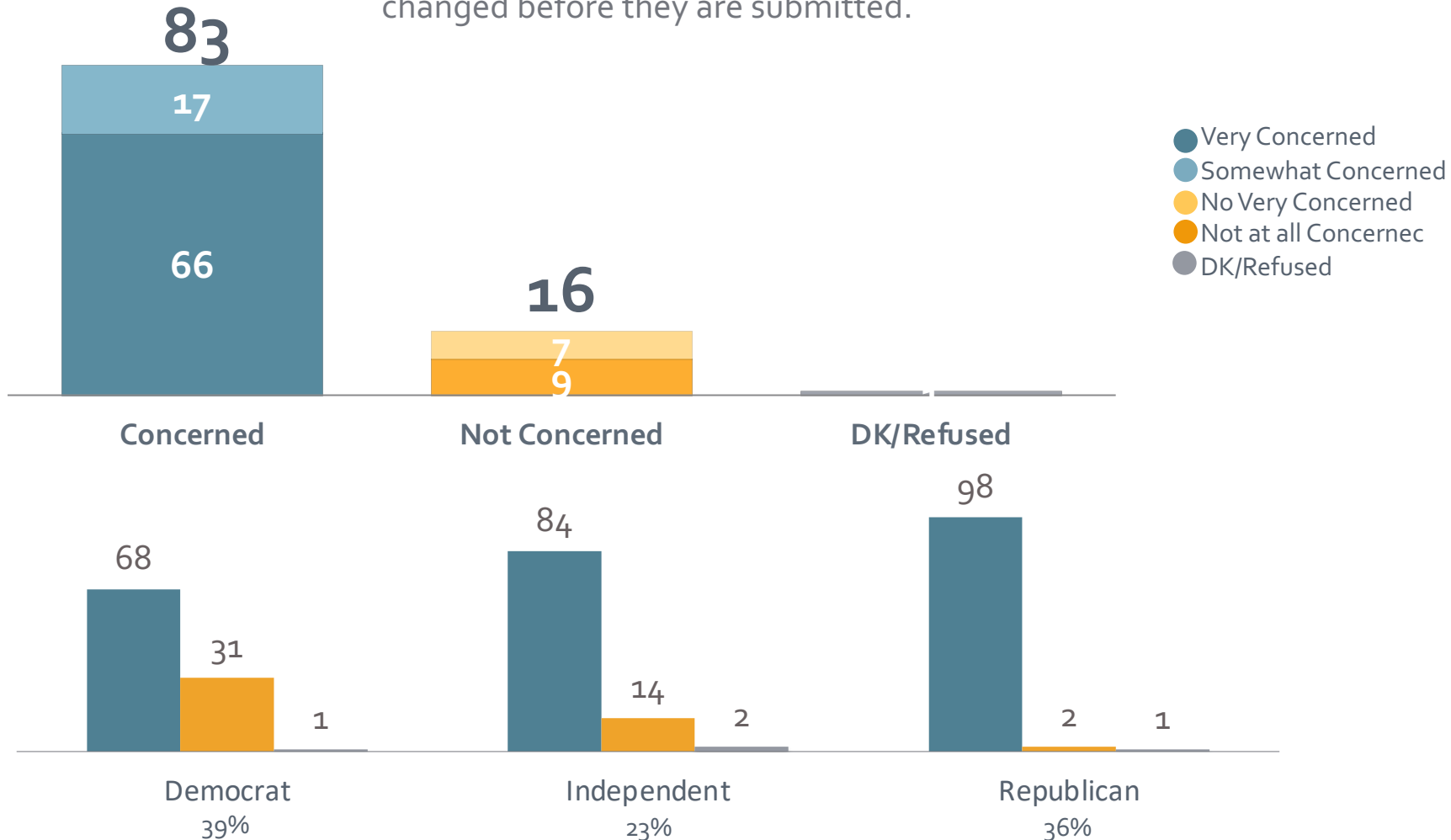

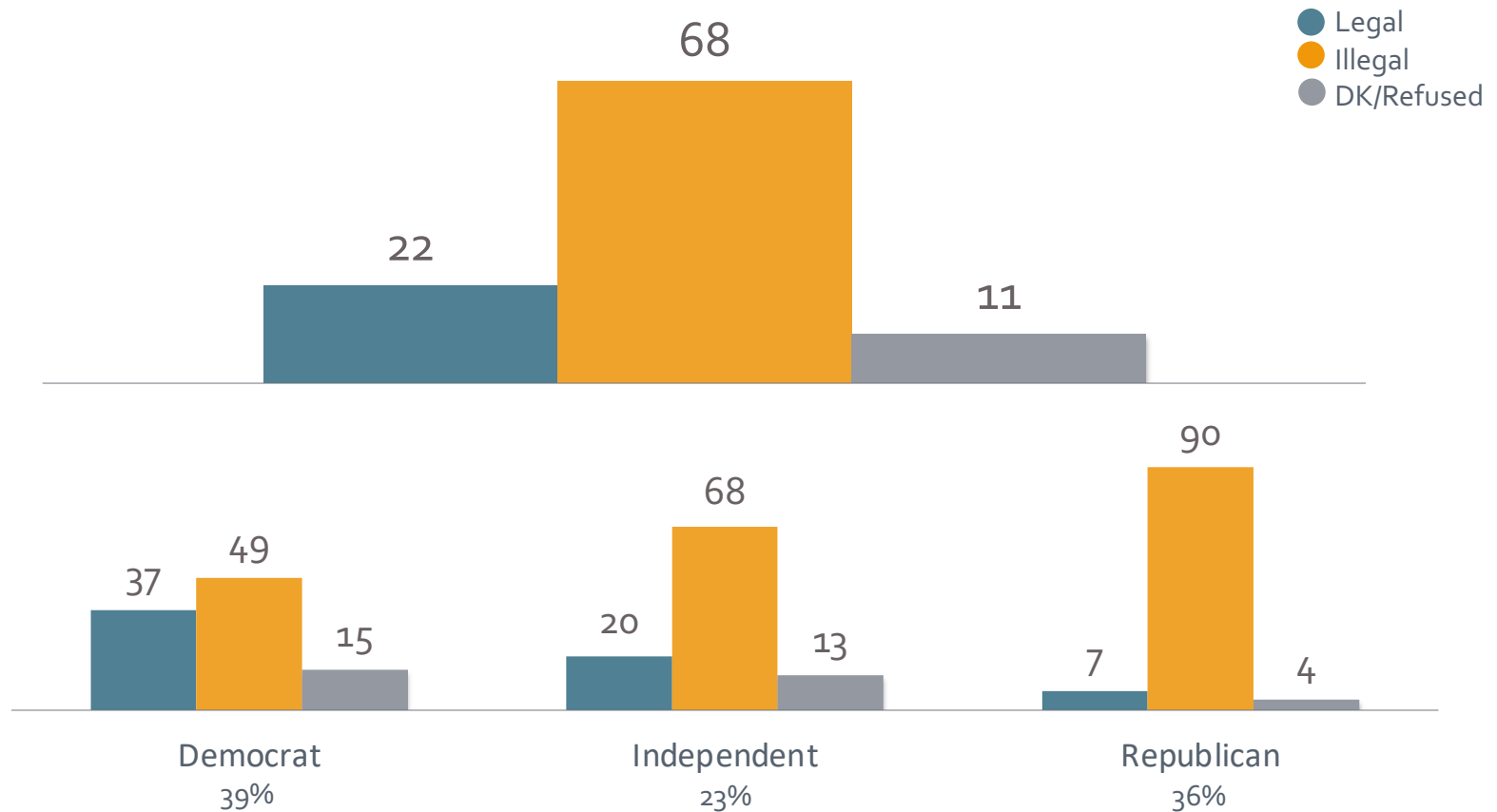
# CONCERN SERIES – BALLOT HARVESTING

Allowing political organizations and activists to collect thousands of ballots and deliver them unsupervised to the county clerk, opening up the chance that ballots could be destroyed or changed before they are submitted.



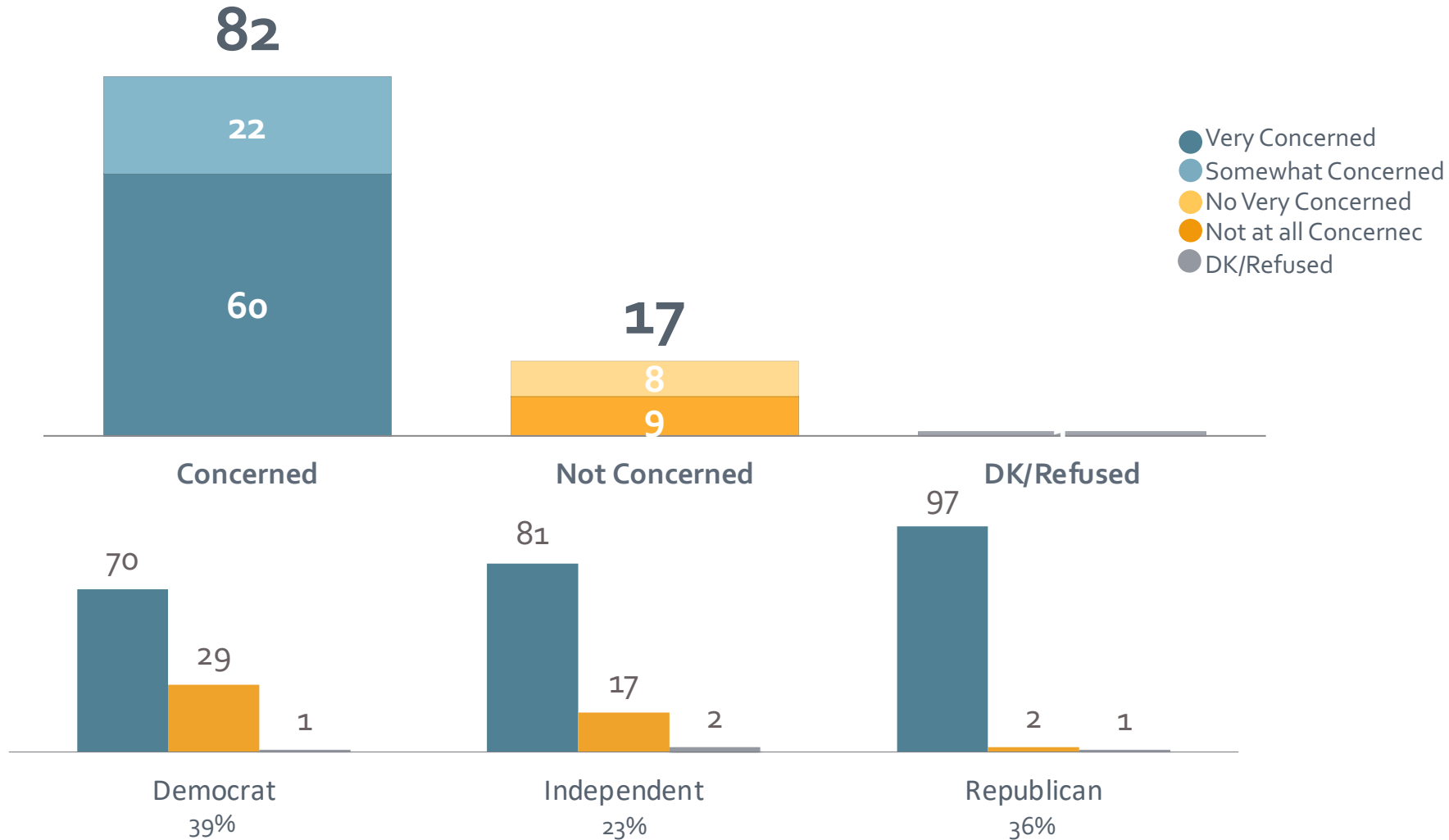
# BALLOT HARVESTING LEGALITY

As you may know many campaigns and political organizations engage in a practice called ballot bundling or harvesting which is having paid activists collect hundreds or even thousands of mail-in ballots and deliver them to the election office or polling place by hand. For example, many campaigns or political organizations sent staff into nursing homes to collect mail-in ballots promising to deliver them to the county clerk's office without the supervision of election officials. With this in mind do you think this practice should be legal or illegal?



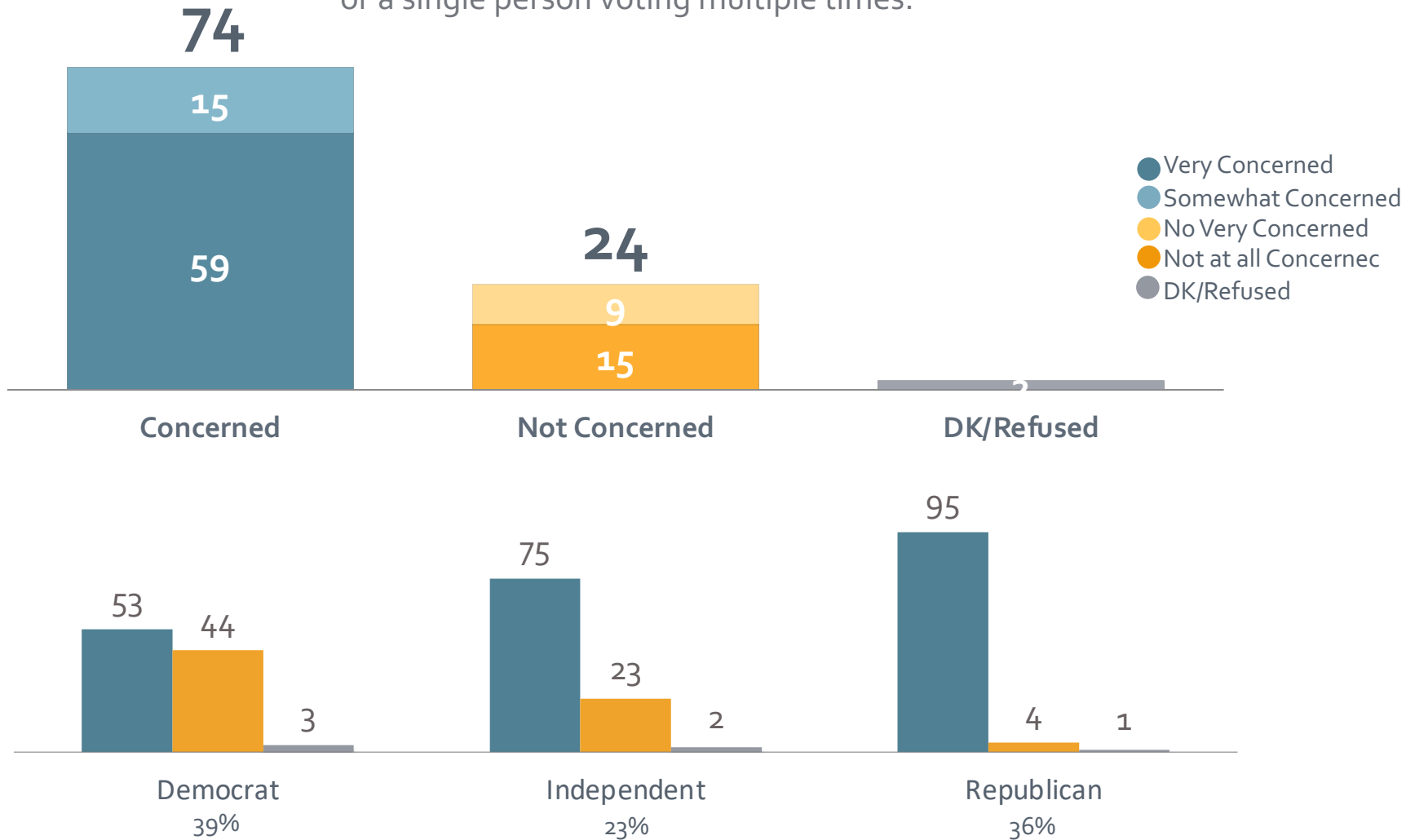
# CONCERN SERIES – VOTER FILE CLEANING

Not requiring states to regularly clean up their voter registration file to ensure that people who have died or moved out of state are removed from the file.



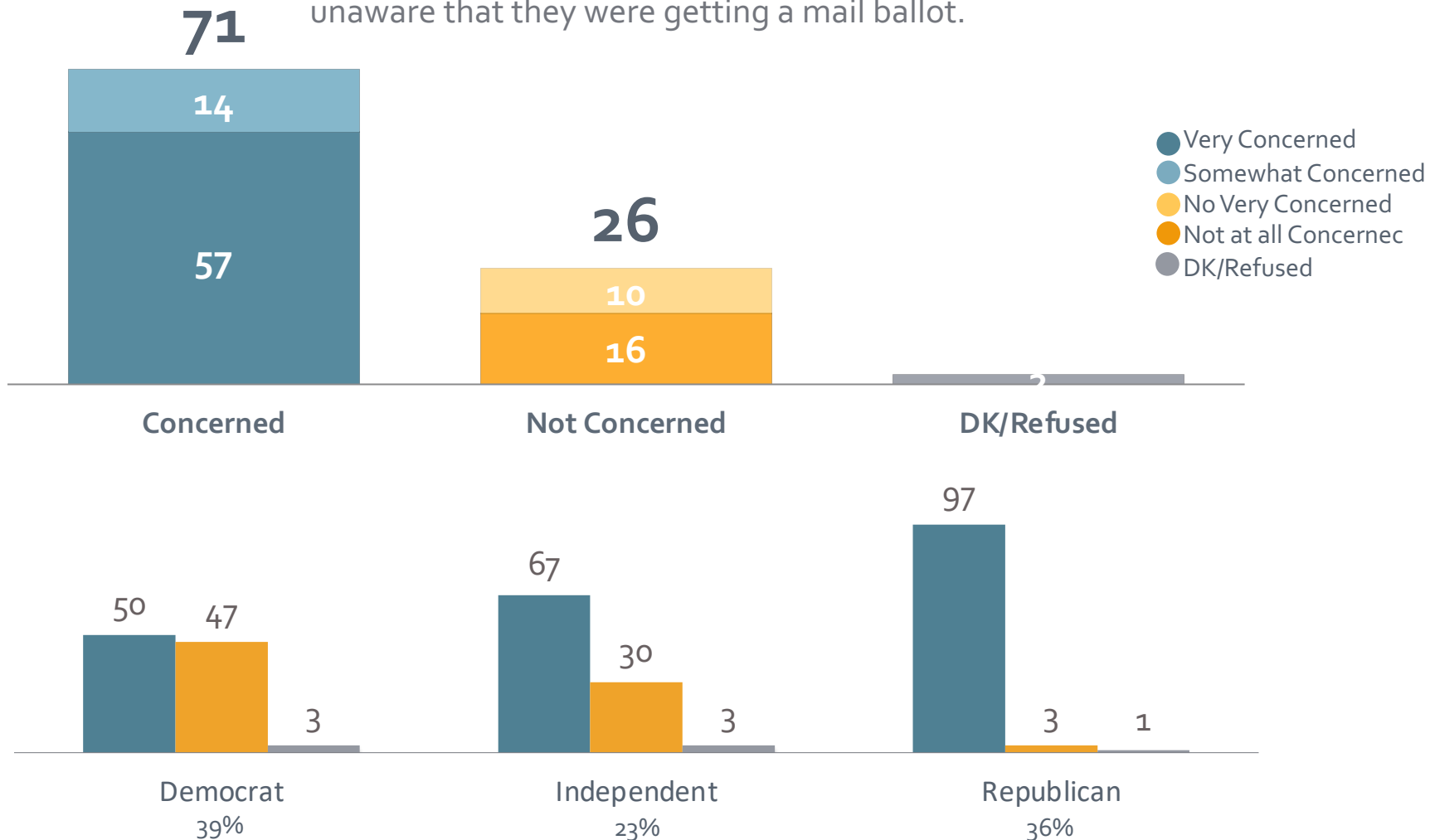
# CONCERN SERIES – REMOTE BALLOT DROP BOXES

Allowing remote ballot drop boxes with no security that can lead to potential ballot tampering or a single person voting multiple times.

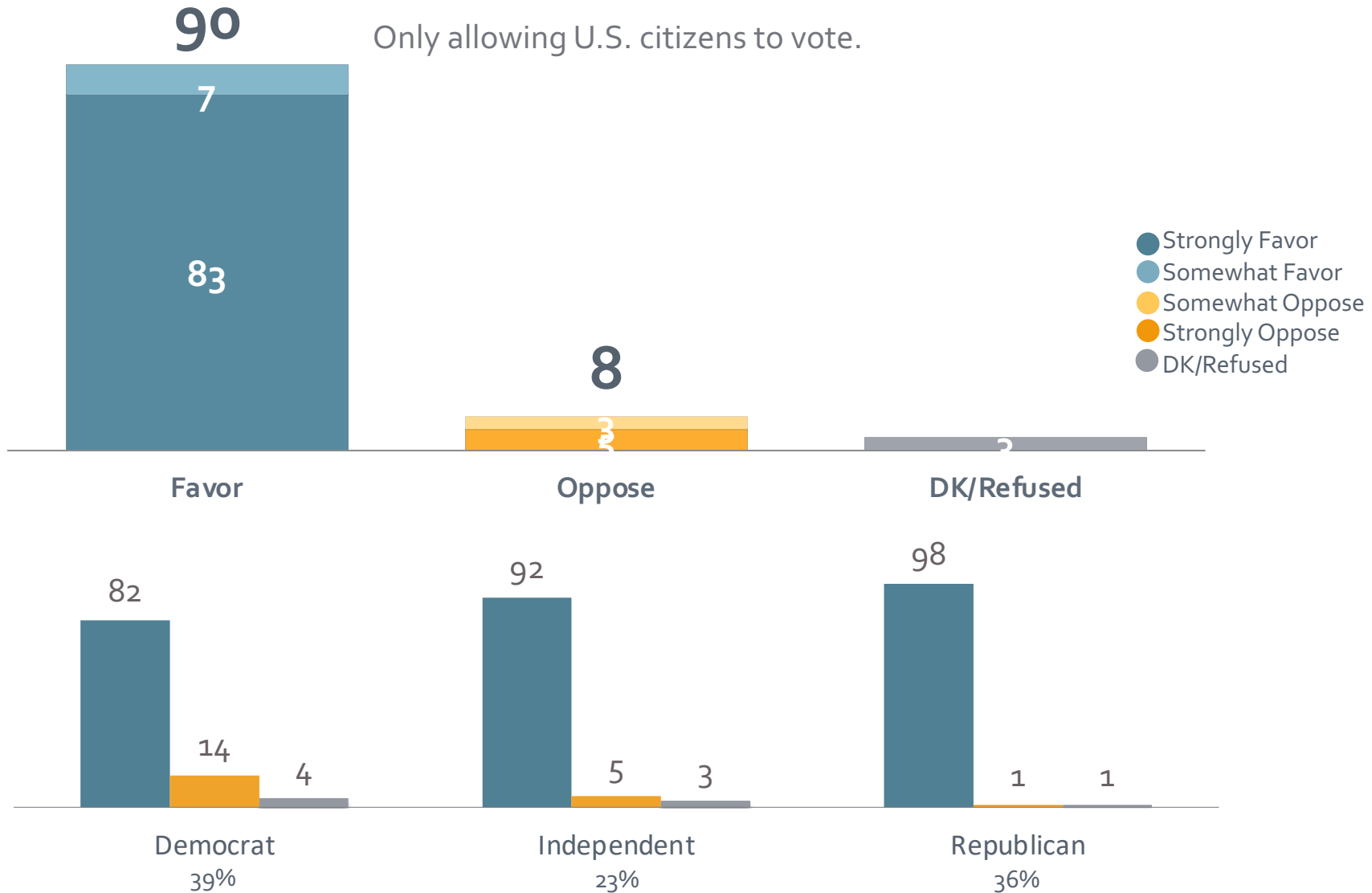


# CONCERN SERIES – UNIVERSAL MAIL-IN VOTING

Mailing ballots to everyone who is registered to vote even if they didn't request it, allowing thousands of ballots to be sent to the wrong address or to be stolen from mailboxes of those unaware that they were getting a mail ballot.

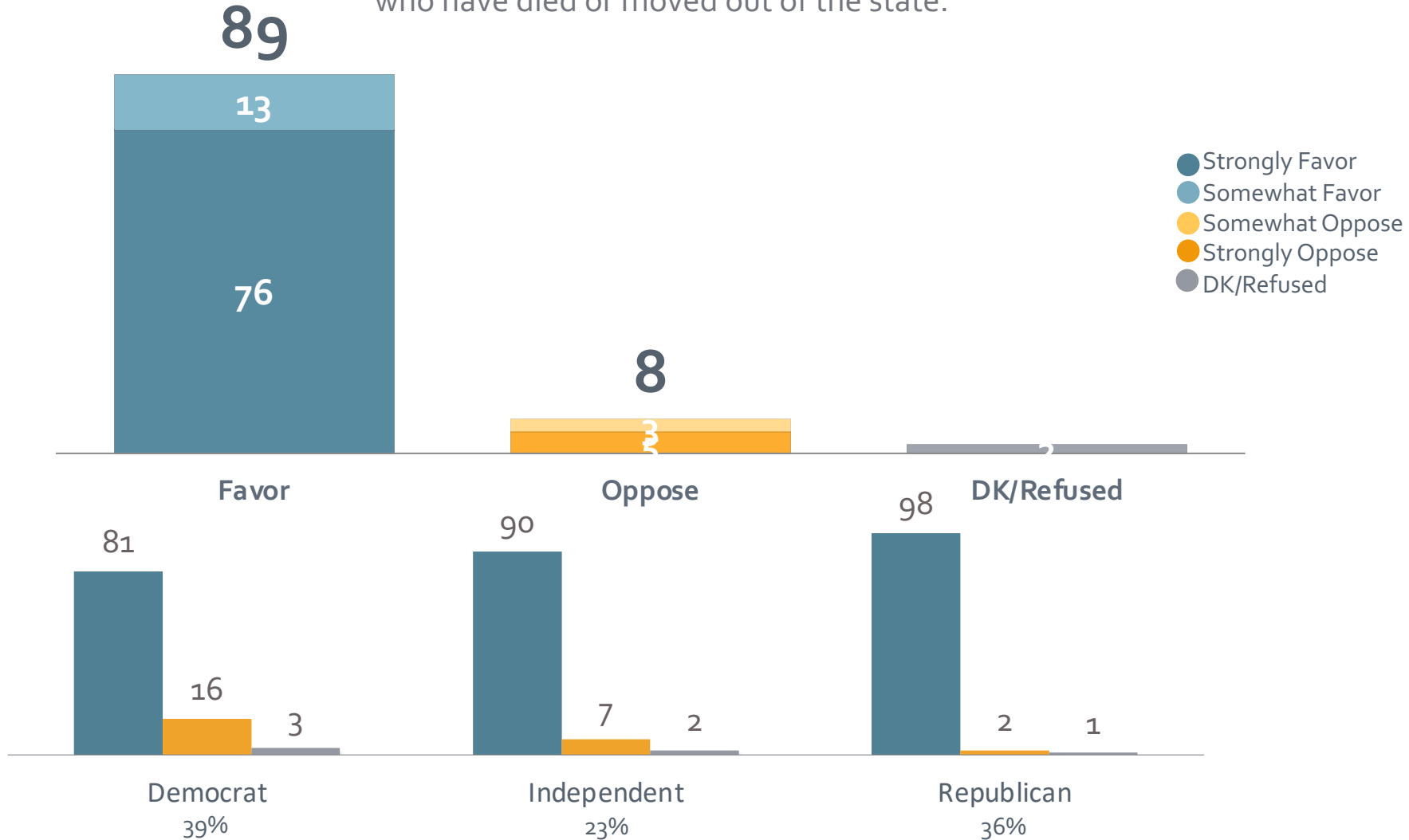


# SOLUTION SERIES – ONLY US CITIZENS VOTE



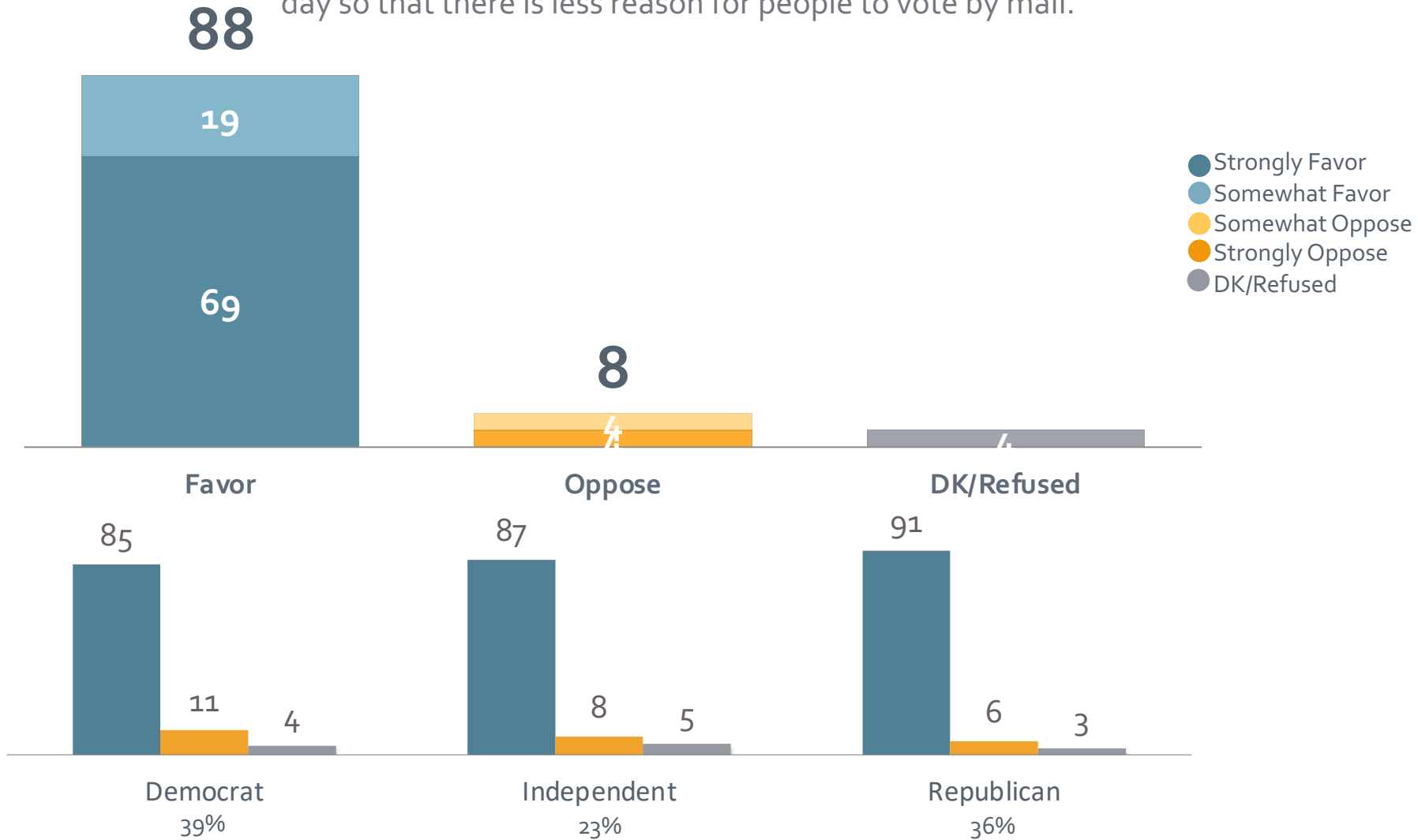
# SOLUTION SERIES – CLEANING VOTER FILE

Requiring states to clean up their voter registration file every two years in order to remove those who have died or moved out of the state.



# SOLUTION SERIES – MORE POLLING LOCATIONS

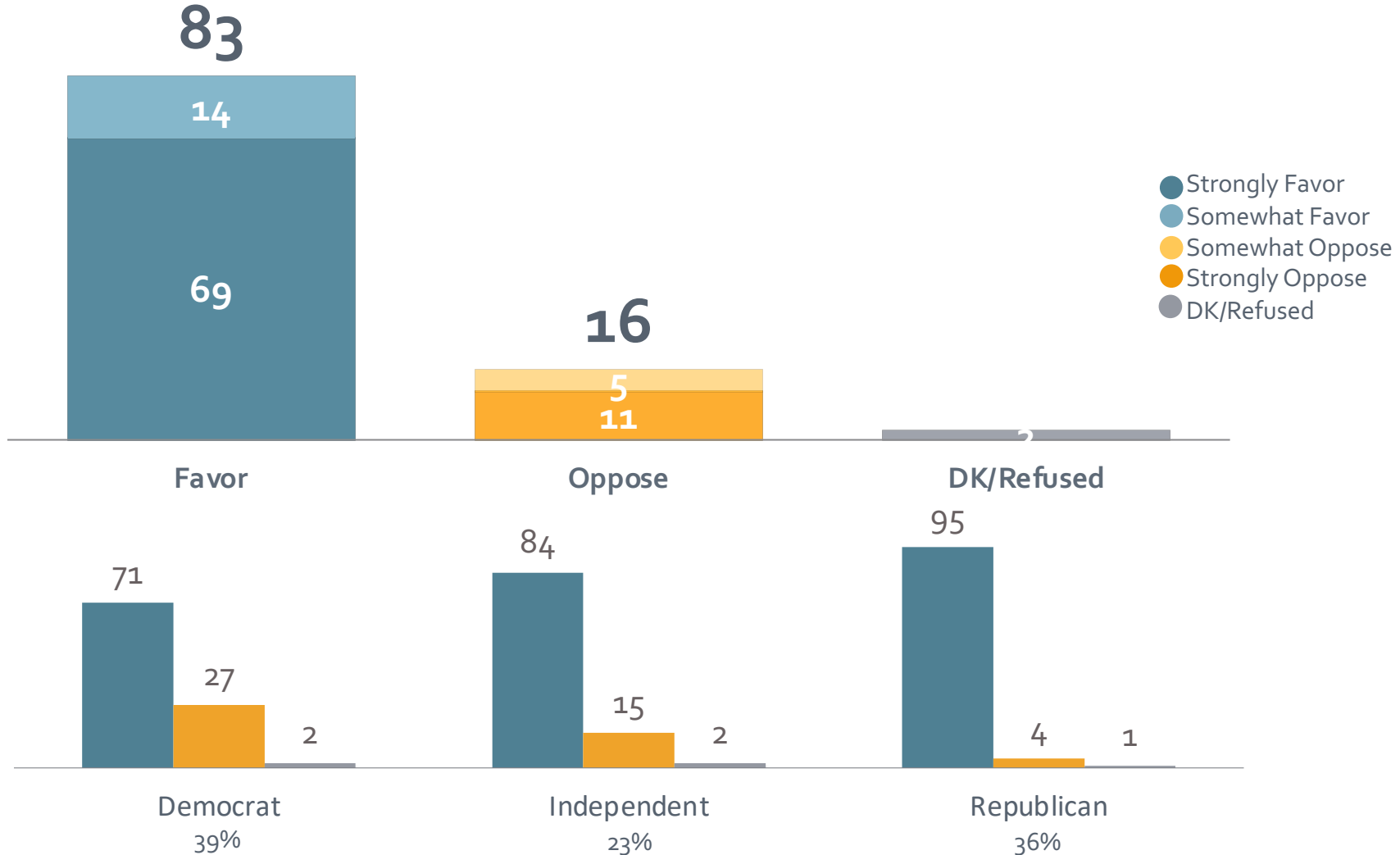
Increasing the number of polling locations and voting machines to reduce wait times on election day so that there is less reason for people to vote by mail.





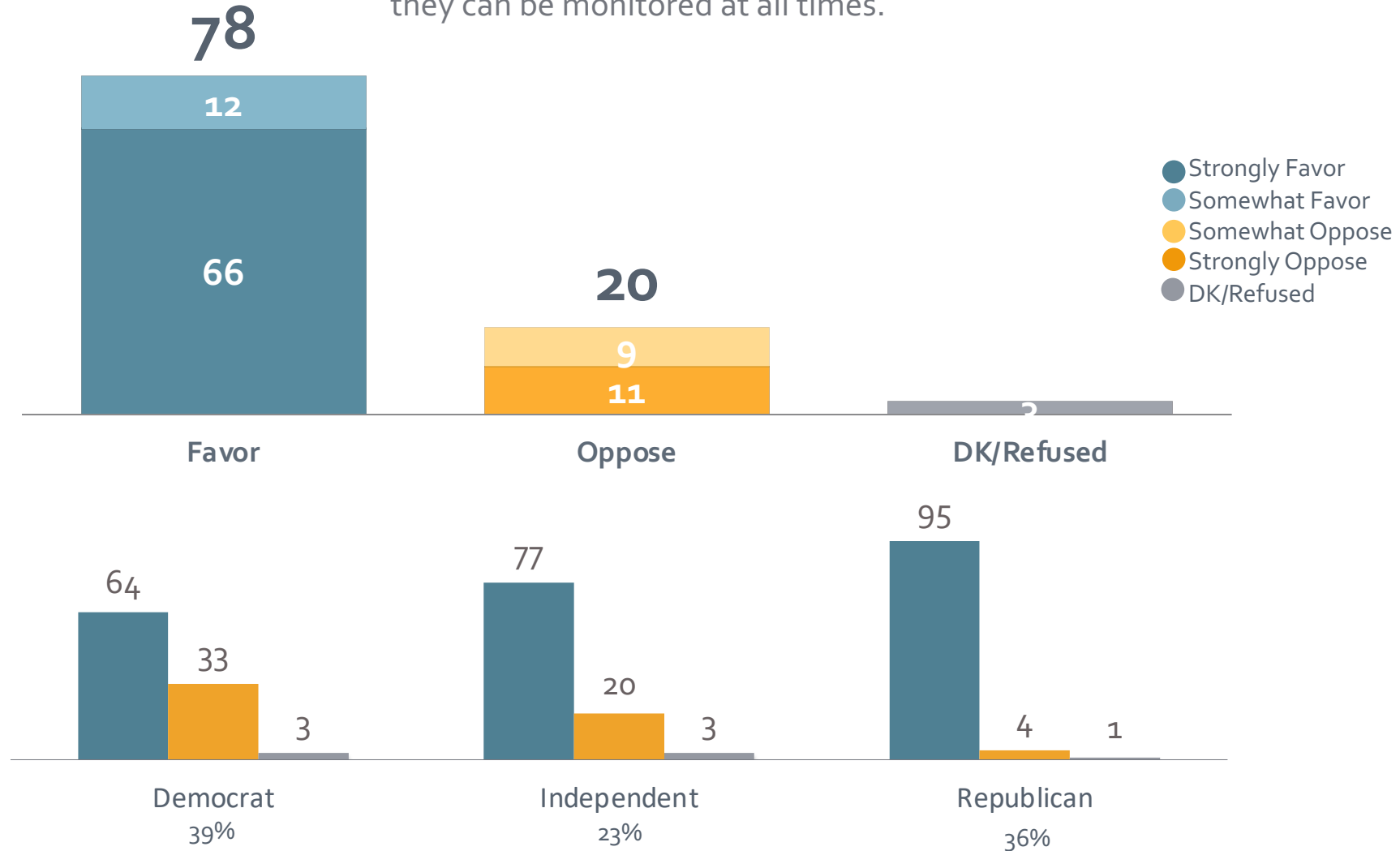
# SOLUTION SERIES – RECEIVED BY ELECTION DAY

Requiring ballots to be received or postmarked on or before election day in order to be counted.



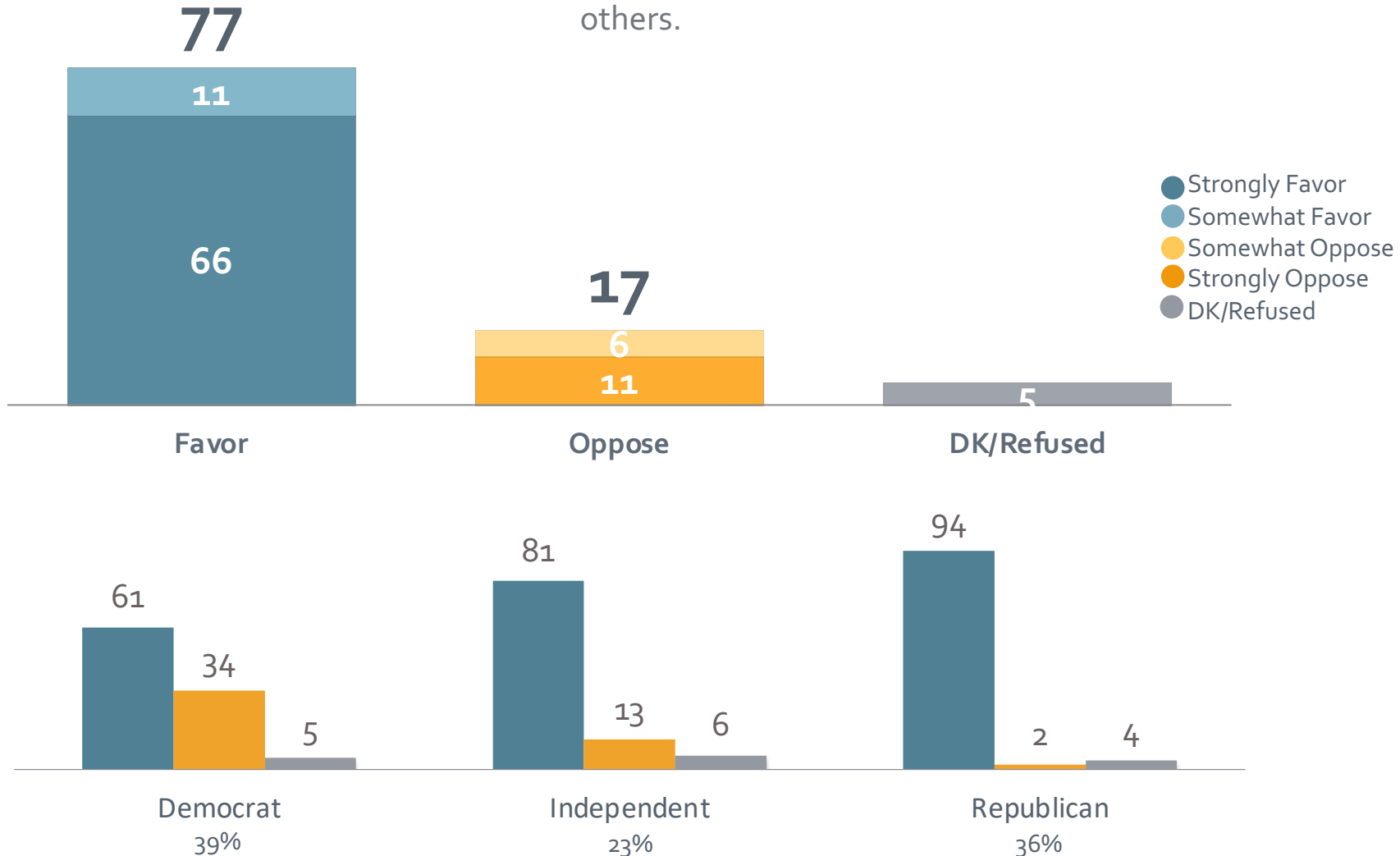
# SOLUTION SERIES – MONITORED DROP BOXES

Requiring all ballot drop boxes to be inside of election offices or other government buildings, so they can be monitored at all times.



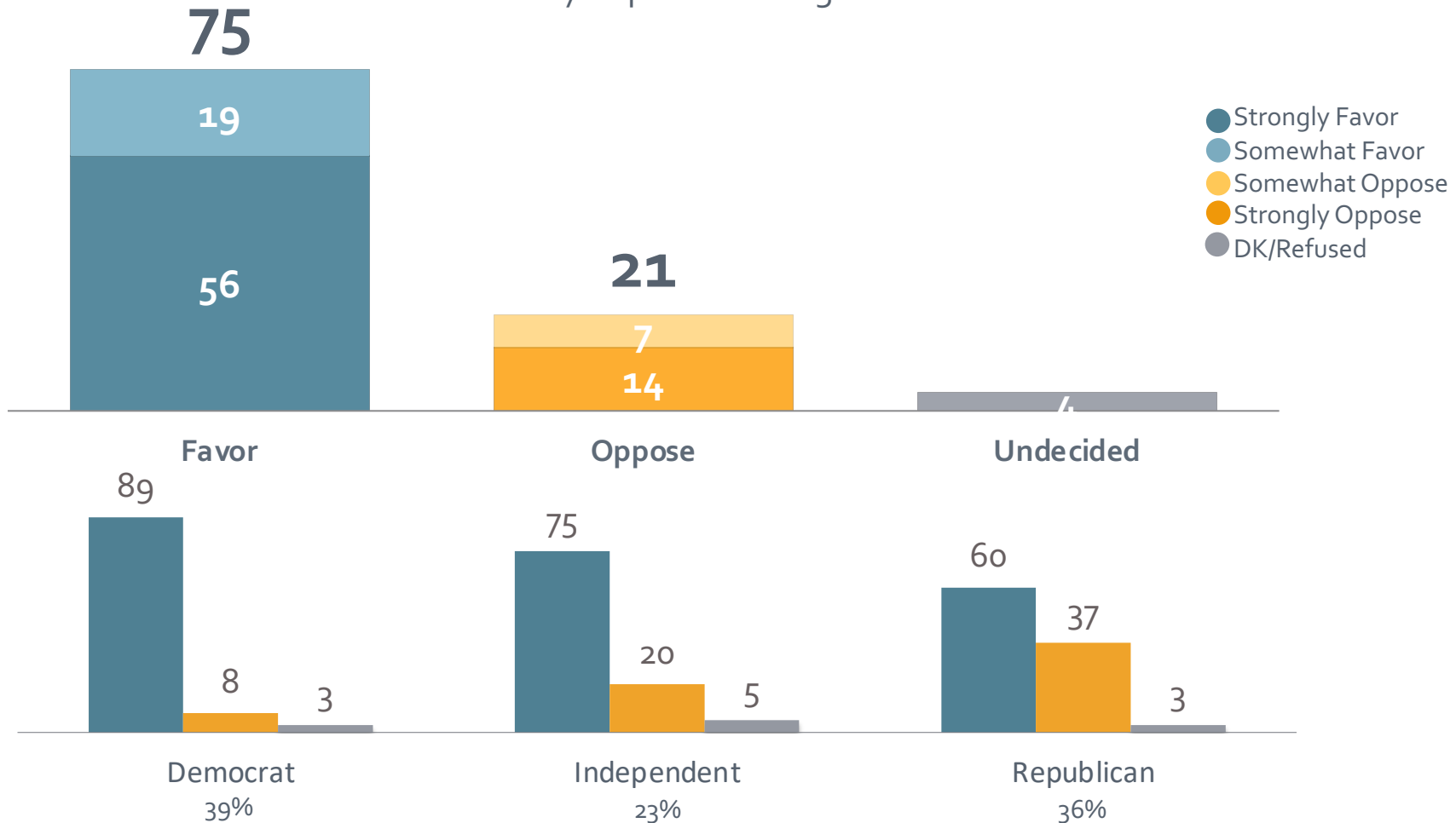
# SOLUTION SERIES – REQUIRE VOTER ID

Requiring voters to present a valid photo ID in order to stop people from fraudulently voting for others.



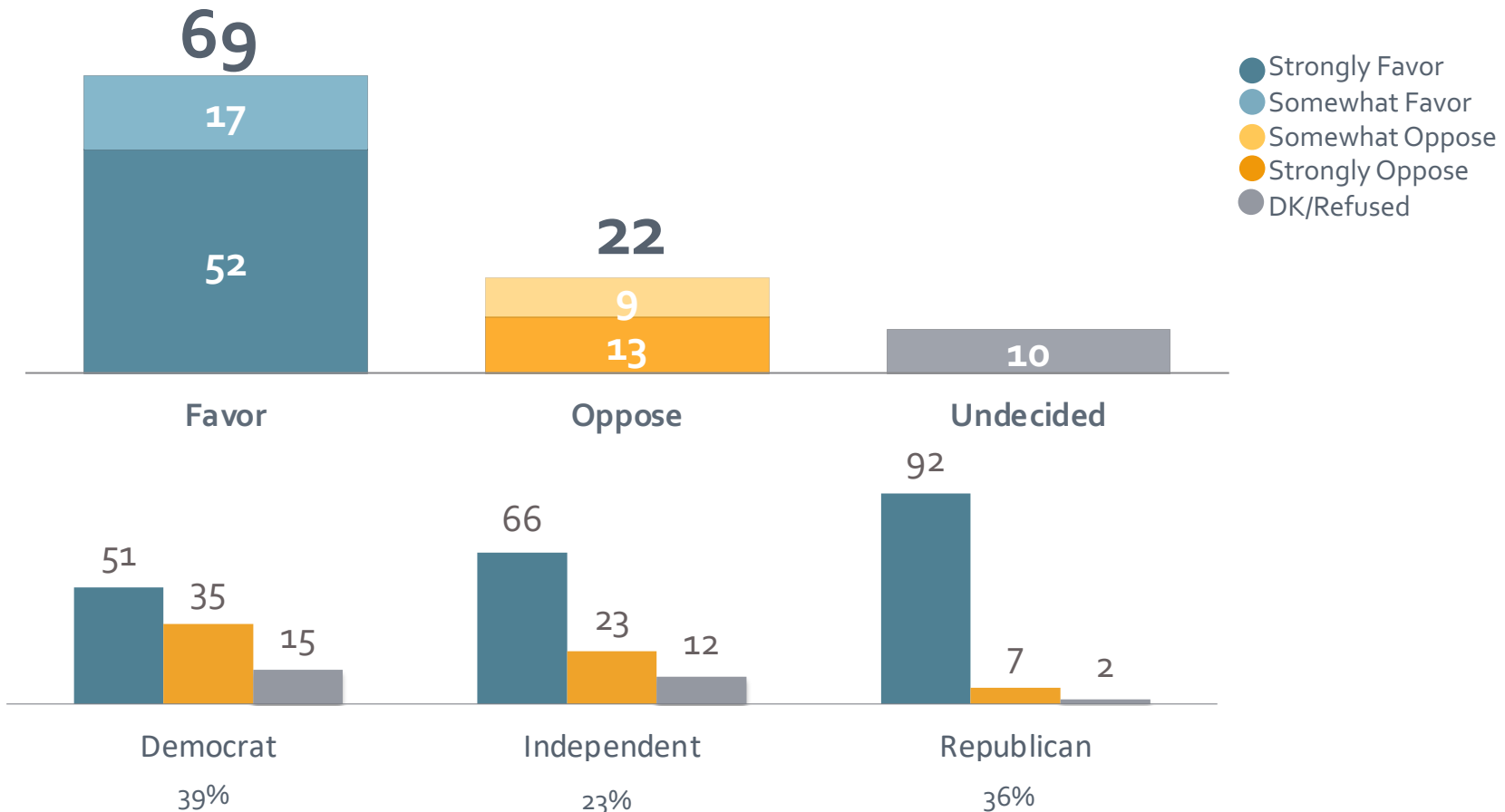
# EARLY VOTING

As you may know, 43 states allow some form of early in-person voting by allowing ballots to be cast up to four weeks before the election. With this in mind do you favor or oppose the practice of early in-person voting.



# REPORTING BALLOTS CAST

As you may know, some states have laws that require all precincts to report the total number of ballots cast within three hours of the polls closing. That's not counting the ballots, it's just reporting the total number of ballots cast. This helps ensure that additional ballots don't show up after election day.
